1. Admission Requirements

1.1. Application

The application form may be downloaded from the website: www.annauniv.edu/cia/adm.php
If the candidate wishes to apply for both CIWGC and NRI Categories, separate applications should be made.

1.2. Eligibility and Academic Qualifications

B.Arch Degree (Five Years): The selection of candidates will be based on the aggregate for 200 of the total marks obtained in the qualifying examination. The qualifying examination is a pass in 12th Grade or its equivalent examination with mathematics as one of the subjects. In addition, the candidates must have passed the National Aptitude Test (NATA) conducted by the Council of Architecture, India (www.nata.in). The aggregate for 200 will be calculated with the maximum marks obtained in NATA. The candidates should submit the NATA mark sheet along with the application.

Ranking of the candidate will be based on the total marks of 400 (NATA 200 and Academic mark 200). Those who have not appeared and passed in the NATA are not eligible for admission to B.Arch. Degree Course.

In cases where more than one candidate has got the same mark in the common merit list, the inter-se-merit among such candidates shall be determined in the order of priority as specified below:

(1.) Academic Aggregate for 200 (2.) Date of Birth (elder will be given preference).

1.3. Registration Fee

A Bank Draft for **US \$ 200** drawn in favour of the **Director, Centre for International Affairs, Anna University, Chennai** payable at **New York** drawn from any Nationalised Banks of India or other International Banks with branches in India should be submitted along with the application.

1.4. Last date for Receipt of Application

Application complete in all respects should reach the **Director**, **Centre for International Affairs**, **Anna University**, **Chennai-600 025**, **India** on or before **06 June 2011**.

1.5. Selection Procedure

After the last date for submission of application, a merit list will be prepared based on the aggregate for 200 of the total score in H.Sc. & the NATA score. The candidates will be called for counseling and the toppers will be allotted the available seats. The counseling will be held at Anna University, Chennai on **20 June 2011.**

1.5.1. At the time of counseling, the following documents are to be produced (in original except item No.4)

- 1. Recent NRI status certificate of the parent issued by the Indian Embassy of the respective country under their seal as per Specimen-I.
- 2. Employment Certificate of the NRI parent as per Specimen-II. In the case of selfemployment, nature of business, annual income and required proof like Income-Tax paid (for the last 3 years), etc.
- 3. NRE / NRI bank account statement of the NRI parent, atleast last six months.
- 4. Valid Indian Passport of the NRI parent.
- 5. Qualifying Mark / Grade list of the candidate****.
- 6. School Transfer Certificate or Migration Certificate.
- 7. NATA Mark Sheet

Note: **** If the candidate has studied in a Non-Indian Government board of education system in abroad or in India, the eligibility certificate obtained from the Association of Indian Universities, New Delhi or Indian Embassy in abroad, where the candidate has studied should be submitted.

1.6. Payment of Tuition Fee:

On receipt of the allotment order, the candidate has to pay the prescribed fee immediately in the form of Demand Draft drawn in favour of the **Director**, **Centre for International Affairs**, **Anna University**, **Chennai** payable at **New York**.

1.6.1. Fee Structure: US\$ 7500 per year for all UG Programmes.

US\$ 36500 - Fee payable in one installment per Course.

1.6.2. Fee once paid is not refundable.

1.7. Fitness:

Candidates have to submit a medical fitness certificate at the time of counseling as per Annexure - II.

2.GENERAL INFORMATION

2.1. Reporting to the University:

Normally, the academic session begins by **July – August** every year. Candidates selected for admission are required to report to the Deans of the campus concerned on the scheduled date mentioned in the allotment order. If the candidate fails to do so, the offer of admission will automatically stand cancelled.

2.2. Hostel Accommodation:

Limited Hostel accommodation is available inside the campus. Application can be made at the time of admission. Interested candidates may apply. They have to pay the prescribed fee as per the Hostel Rules. The Hostel Mess is run on dividing system.

2.3. Other Fee:

Fees applicable for Library, Examination, Students' Co-operative Society, Identity card(Smart card), etc should be paid in Indian rupees at the time of admission or when required to pay as per the rules.

2.4. Requirements for Completion of a Semester

2.4.1. A candidate who has fulfilled the following conditions shall be deemed to have satisfied the requirements for completion of a semester.

Ideally every student is expected to attend all the classes and earn 100% attendance. However, in order to allow provision for certain unavoidable circumstances such as hospitalization / accident / specific illness, the student is expected to earn a minimum of 75% attendance.

Therefore, he / she shall secure not less than 75% of overall attendance in that semester taking into account the total number of periods in all courses attended by the candidate as against the total number of periods in all courses offered during that semester.

- 2.4.2. However, a candidate who secures overall attendance between 65% and 74% in that current semester due to medical reasons (prolonged hospitalization / accident / specific illness / participation in Sports events) may be permitted to appear for the current semester examinations subject to the condition that the candidate shall submit the medical certificate / sports participation certificate to the Head of the Department. The same shall be forwarded to the Additional Controller of Examinations, Anna University, Chennai for record purposes.
- 2.4.3. Candidates who secure less than 65% overall attendance and candidates who do not satisfy the clauses 2.4.1 & 2.4.2 will not be permitted to write the end-semester examination of that current semester and will not be permitted to go to the next semester. They will be required to repeat the incomplete semester in the next academic year.
