1.0 ADMISSION REQUIREMENTS

1.1. Application

The application form may be downloaded from the website: www.annauniv.edu/cia/adm.php.

1.2 GENERAL ELIGIBILITY

1.2.1. M.S (By Research)

- I. Bachelor's Degree in Engineering / Technology / Architecture / M.Sc in Science & Humanities of the University or any other qualification recognized as equivalent thereto in the fields of study notified from time to time by the University. Specific educational qualifications are given in Clause 1.3.
- II. For Engineering, minimum of 55% marks or CGPA of 5.5 on a 10 point scale in the qualifying examination. For M.A.(English) Degree holders, a minimum of 50% marks or CGPA of 5.0 on a 10 point scale.

1.2.2. Ph.D. Degree

- I. Masters' Degree of the University or any other qualification recognized as equivalent thereto in the fields of study notified from time to time by this University. Specific Educational Qualifications are given in Clause 1.3.
- II. For Engineering minimum of 55% marks or CGPA of 5.5 on a 10 point scale in the qualifying examination. For M. A.(English) Degree holders minimum of 50% marks or CGPA of 5.0 on a 10 point scale.
- III. The Clause II does not apply, if the qualifying degree is M.S (By Research) of the University or recognized as equivalent.

- 1.2.3.** Candidates who satisfy the eligibility criteria as in Clause 1.2.1 & 1.3 are eligible to apply for M.S. (By Research). Programme, and Clause 1.2.3 & 1.3 are eligible to apply for Ph. D. Programme.

Candidates under Full-time scheme shall do research work in the University and shall be available during the working hours for curricular, co-curricular and related activities.

1.8 Examination fee for Course Work

(By Research) scholar as recommended by the Monitoring Committee. The required Examination fee per course work is to be paid as notified by the Controller of Examinations.

A maximum of four PG level courses are to be studied and examinations are to be undertaken by a Ph.D. scholar as recommended by the Doctoral Committee. The required Examination fee has to be paid as notified by the Controller of Examinations.

1.9 Synopsis Fee (Payable at the time of submission of Synopsis)

Synopsis Fee : Rs. 6,500/- (including Provisional Certificate and Degree Certificate fee) to be paid by M.S. (By Research) and Ph.D. students.

1.10 Selection of candidates :
